web using the proper phrase is simply a matter of identifying the phrase's role in the sentence in grammatical terms i is a subject pronoun and me is an object pronoun that means you would use i to express that you yourself are performing an action and me to indicate you are receiving an action as understood in those terms you and i is the right phrase when we web both i and me are 1st person singular pronouns which means that they are used by one person to refer to himself or herself i is the subject pronoun used for the one doing the verb as in these examples i am studying for a russian test i is the subject of am studying i can speak russian but i can't read it very well web aug 20 2011 i is of course

the normal subject pronoun and me is the normal object pronoun but in this style me is also an emphatic variant of i that is used among other uses whenever several nouns or pronouns are joined into a single subject or object this is the most correct style in the sense that it is how educated normal people normally speak web the phrase somewhere for you and me to go is correct because if we remove you and we re left with somewhere for me to go great that s how the language rule works similarly you and i can t be out too late becomes i can t be out too late in the same manner to help with your understanding even more you and i usually comes at the web dec 26 2019 both i and me are pronouns that we use to refer to ourselves but i is nominative suitable for use as the subject of a sentence or clause and me is accusative suitable for use as the object of a verb nominative the nominative case is used when the pronoun is the subject e g i rode in the car or when speaking very formally after a web the correct word is me assuming that the phrase is a shortened form of this came from jennifer and me in that phrase the subject the noun pronoun performing the verb is this if jennifer and i were performing the verb as in jennifer and i gave this to you it would be i terry kureth web use the pronoun me when the person speaking is receiving the action of the verb in some way either directly or indirectly it can be difficult to know which one to use when a sentence has a compound subject or object especially since many people use me in subject position and i in object position in speech and this is ok to do web me is used as the direct or indirect object in a sentence and is always used to express the object of the message a good trick to remember whether you should use

me in a phrase would be to ask the question to whom or for who if me answers any of these questions then it is certainly an object and should be used in the sentence web when the group of people including you is the subject of the phrase list the people first followed by and i when the group is the subject it s all the other people plus and me it s worth noting that even though many people will say and myself instead of and me usually to sound more formal this is technically not correct web nov 4 2019 the best way to know when to use i and me is to identify whether the word is being used as a subject or an object if it s the subject of a sentence the one performing an action or being something you should use the word i after i opened the presents i was very happy i asked jim to help with the project
